Invitations are hereby invited for organizing the 29th Mid-term CME, 30th Mid-Term CME 2020 and 51th Annual Conference 2020 of IPSWZB.

01. Any member may send the invitation for above mentioned program. Hon. Secretary of any of the local State Branches of IPS, WZB falling under the zone may also extend their invitation on behalf of the local, State Branch or society.

02. 03. If there is more than one invitation, then all invitees will be informed about the same and they will be given a chance to withdraw their invitation, if one wishes to do so. The last date of withdrawal will be **15th September 2018.** The final decision will be taken at the 49th AGBM of IPS-WZB.

04. It should be noted that:

(a) The organizers of the Mid Term CME program have to pay, before valedictory function of the Mid Term CME.

(1) Rs. 20,000/- to “Archives of Psychiatry” the Journal of IPS-WZB.

(2) Rs. 100/- per registered delegate to IPS-WZB. The organizers may charge this amount separately from delegates as contribution to IPS-WZB.

(b) The organizers of the Annual conference have to pay before valedictory function of the Annual Conference.

(1) Rs. 40,000/- to “Archives of Psychiatry” the Journal of IPS-WZB.

(2) Rs. 200/- per registered delegate to IPS-WZB. The organizers may charge this amount separately from delegates as contribution to IPS-WZB.

(c) 50% (if organized by a branch, recognized by IPS) or 100% (if organized by an individual member or non recognized branch/society) of the surplus amount must be remitted to IPS- WZB along with the audited statement of accounts compulsorily.

The audited statements & the contribution No. 1 & 2 of (a) & (b) is compulsory even in case of the organizers incurring financial loss.

Shah Best Paper Award”. The first author must present the paper.
2. 50% of the authors including, the principal author must be members of the I.P.S Western Zonal Branch. In case of student authors, minimum an application for membership of I.P.S must have been made and fees paid. The covering letter should mention the membership status with membership number (Please submit the Xerox copy of membership receipt) and should be signed by all the authors.
3. The paper winning the title must be presented at the “BPS Silver Jubilee Award” Session at the 71st ANCIPS to be held at Lucknow during 31st January- 3rd February 2019. The principal author must sign an undertaking to this effect. The fellow nominated for the office of Vice President-cum President Elect must be a fellow of the IPS for at least 10 years, and must have served the Zone at least for one full term as a member of EC. The fellow nominated for the post of Honorary Secretary must be a Fellow of the IPS continuously at least for 5 years and must have served at least for one full term as a member of EC. A fellow can propose or second only one candidate for one particular post. The fellow nominated must express his consent in writing to be nominated for the said post and has paid up all his membership dues including the current financial year. The nomination paper shall contain signature of Fellow who have paid their annual subscription for the current year before filling the nomination.. The nomination paper shall contain signature of those fellows either as Candidate, Proposer or Secunder who have paid their annual subscription for the current financial year before filling the nomination and should submit the Xerox copy of the receipt.

02. A brief bio data of the nominee of not more than 100 words must be sent along with the nomination.

03. The nomination should be sent in a sealed envelope on which “**Nomination: “Name of Post”**” shall be mentioned. If it’s Vice President, Honorary Secretary, Honorary Treasurer, Honorary Editor, EC Member (General Category) OR EC Member (Female Category).
