(c) 50% (if organized by a branch, recognized by IPS) or 100% (if organized by an individual member or non-recognized branch/society) of the surplus amount must be remitted to IPS- WZB along with the audited statement of accounts compulsorily.

The audited statements & the contribution No. 1 & 2 of (a) & (b) is compulsory even in case of the organizers incurring financial loss.
